### **THE PRESIDENT'S COLUMN**

Dear Friends:

One of the original goals of the group that founded the Friends of the Texas Room was to educate the public at large about the scope and depth of the archival collections at the Houston Metropolitan Research Center. We quickly realized that most people do not understand the difference between a library and an archive. Our first task, therefore, was to explain that difference. A library is a place to do reference work and to check out books to take home. An archive is where original, historic, one-of-a-kind materials (maps, documents, letters, photographs, early newspapers, rare books, etc.) are held for the purpose of preservation and research. Archives require special temperature and humidity controls, special security, and shelving and cabinetry for storage that are different from those required for a library.

Recently one of our members, Mr. James R. Bailey, owner of Sunset Productions, offered to produce a comprehensive video documentary on the extensive holdings of the HMRC. Mr. Bailey produced the documentary, "The Golden Age of Texas Courthouses," which aired recently on Channel 8. He also produced an upcoming program on Channel 8 entitled "Brushstrokes of South Texas" about a series of murals in the Kenedy Ranch Museum by artist Daniel Lechon depicting the history of South Texas. Mr. Bailey and FTxR board member, Nancy Burch, who frequently collaborates with Mr. Bailey on productions, have offered to produce our video at cost, donating their own time. They propose to produce a video of 28-30 minutes in length of the highest caliber worthy of being shown on public television.

The plan is to have an eight-to-ten minute introductory segment that can be excerpted to stand alone. This segment will be a general overview of the scope of the collections and will cover topics such as the newspapers going back to the 1830s, the city directories going back to the first one published in 1866, the criss-cross directories, and other tools which are used by most HMRC patrons at one time or another. Taken together, these sources alone could be used to trace the history of Houston from its earliest days during the Republic of Texas.

The rest of the video will consist of a series of segments, each lasting several minutes, focusing on areas of special strength and concentration such as architecture, maps, rare books, and photographs. Like the introductory segment, these segments could be excerpted and used as stand-alone pieces. We see many uses both for the video as a whole and for the stand-alone segments. We anticipate that one of the first uses can be as an aid in raising the money to renovate the Ideson Building and build the new wing for the HMRC.

The Library Administration has agreed to contribute \$8,000 toward the \$20,000 total cost. For fund-raising purposes, we plan to divide the remaining \$12,000 into segments of approximately \$3,000 each (corresponding to the individual segments listed above). We welcome any and all ideas about individuals, corporations or foundations that might be interested in funding one of these

segments.

The Board has voted to spend \$1,300 of its share of the budget for the video, which will be matched by \$1,300 from the Library's share, to fund the photographing of the archival materials selected to be featured in the documentary. The photographing must be done this fall, because the rooms where the photographing will take place will become office space in January. (Staff members from the Jones Building will move temporarily into the Ideson Building while the Jones Building is being renovated.) The film will be stored until we have raised the \$12,000. We are in the process of identifying potential sources of funding and expect to begin making contacts within the next few weeks.

We will keep you posted on the progress of this exciting project.

**MINUTES  
FRIENDS OF THE TEXAS ROOM  
JULY 18, 2005**

Friends of the Texas Room met Monday, July 18, 2005, at 7:00 p.m. at the Museum of Printing History, 1324 W. Clay. President Dorothy Knox Houghton called the meeting to order, after which the minutes of the April 23 meeting were approved as printed in The Texas Room Dispatch. Treasurer George Werner reported that we currently have a balance of \$18,460.24; this figure does not reflect a contribution of \$500 from ExxonMobil that was received in the mail that day.

Brenda Tirrell, manager of Central Library, addressed several issues that had been posed to the Houston Public Library staff by our board. She explained that the amount of \$865,000 reported in a recent newspaper article as being available for the renovation of the Julia Ideson Building was actually the unspent funds from the original \$1 million appropriated for this renovation by the previous city administration. This money will be used for Phase 1 of the JIB renovation which will include converting first floor space (the Auditorium, Norma Meldrum Room, and Harriet Dickson Reynolds Room) to meeting rooms, creating a new entrance and restrooms for the realigned Auditorium space, and meeting ADA standards for the existing restrooms and elevator. This will enable JIB to be used as a support facility for central services when the Jesse Jones Building closes for renovation later this year. Hopefully, funding will be available for the remaining work on JIB when the Jones Building reopens in 2 to 2 ½ years. Ms. Tirrell reported that the retrospective conversion of the HMRC map collections, which Friends of the Texas Room agreed to fund, should be completed by mid-September. She then introduced Steven Strom, who has returned to the

Houston Public Library as manager of the HMRC. Mr. Strom introduced the following new staff members: Ron Dreese, Archivist I; Tammy Jordan, Archivist II; and Kandra Leonard, Supervisor of Support Services. Mr. Strom also announced that the HMRC will stage an exhibit in the fall on the 400<sup>th</sup> anniversary of the publication of Don Quixote.

President Houghton announced that our membership brochures are now available to be used in recruiting new members. She also announced that a Membership Mixer will be held on September 26 from 7:00-9:00 at Story Sloane's Gallery on Fondren. Members were encouraged to invite prospective members to the event. Mr. Sloane has offered to give photographic posters to anyone who joins that evening.

The president introduced Paul Homeyer, who presented an enlightening talk on "Unmasking Main Street," which revealed in photographs the many buildings downtown that had been slip-covered over the years.

Following the program, the meeting was adjourned at 8:15 p.m.
